More than 17,000 adverse events following vaccination were reported to the FDA to have occurred in the U.S. in a 20 month period ending in July 1992, including more than 2000 serious reports and 360 deaths. However, because the FDA estimates that only 10 percent of doctors report adverse events, the real numbers could be as high as 170,000 adverse events, including 20,000 serious injuries, and 36,000 deaths.
