# "THAT PURIFYING BLESSED HOPE" GENESIS 3:15-20;

## PART 14: "THE MOTHER OF ALL LIVING"

- I. HE CALLED HER NAME "CHAVAH", LIFE
  - A. She had been "isha", of the man, "ish"
  - B. Adam had the <u>authority</u> to name her as he had to name the other residents of the Garden
  - C. Her name means "life" for in her is the life of the planet!
    - 1. Naming her indicates he believed the promise of God concerning their <u>continuing</u> life
    - 2. With that name he indicates the faith that in her was residing the "seed" that would deliver them from the disorder and death they had just brought on themselves and the rest of the world
    - 3. The whole planet would be plunged into suffering because of them and the <u>redemption</u> of the planet depended on her and her motherhood. Rom 8:18-23; 1 Tim 2:13-15
  - D. Because of their shortened life span, God increased the number of possible conceptions (once a month now) but with it brought pain, pain in childbirth, and conflict with her husband. The mission of filling the planet had not changed
  - E. The most important promise given in this passage is the delivery of the planet through her seed. Her seed would be in conflict with the seed of the satan. Her seed would win though wounded in it.

- II. HER SEED WOULD BE THE DELIVERY FROM THE TYRANNY OF THE WICKED ONE AND DEATH
  - A. This <u>prophecy</u> was given to satan and it involved her because she believed his deception
  - B. There would be harsh conflict between satan and the woman until the time the two seeds ended the conflict. Notice, it is God who puts the enmity there for they had already had a deceptive time together before and the risk was present they might again.
  - C. To be noted, the word seed in each case is <u>singular</u> and not <u>plural</u>. It will not be multiple seeds that will be in the final conflict but one of each of them.
  - D. This would mean that each and every mother could hope that her son was the Deliverer. But there would be many conflicts of the seeds of each until the final.
  - E. Satan would not know which of her seeds would be the final one, but he would watch and do all he could to destroy the potentials by every deadly and lying path.
  - F. He would follow the trail of God's <u>revelation</u> seeking to destroy the One who might be the Last Seed. Multiple deceptions and persecutions followed
  - G. Jesus, of the seed of the woman, was a surprise to the wicked one. He was not half anything! He was fully God, fully man. Son of man, Son of God
  - H. What Jesus did in the crucifixion, resurrection and ascension set up the final conflict and defeat of the wicked one. All from a mother in Israel! Rev 12
