In the summer of 1897, police officers in California began searching for “a woman living in Stockton in the garb of a man.”

The search ended on a Sunday night in August 1897, after police intercepted and arrested young adult Babe Bean, who was heading to a local church to listen to music, for ‘masquerading in male attire.’

This year, at least six states passed laws to restrict drag shows, and at least eight more introduced similar laws...

The first cross-dressing law was passed in St. Louis in 1843...and dozens of cities soon followed in a “tidal wave” of similar laws.

The anti-cross-dressing laws were an attempt by a particular set of people, the White middle-class merchants...The stars of modern drag shows often are people from diverse backgrounds who identify as LGBTQ...

A few days after **their [Legion?] arrest and release, Bean wrote **their** life story down for the Call, the local newspaper, noting that passing as a man to travel and to work was not a crime. 'I had always loved horses and rode frequently, always astride, as I found it the most convenient and comfortable by far'...**

...as laws got stricter, Bean couldn't safely switch between presenting as masculine or feminine in public. Bean lived the last three decades or so of **their** life as Jack Bee Garland, presenting as a man..."

Why are the Texas Rangers the only MLB team without a Pride Night?

All but one of the 30 of the Major League Baseball teams are hosting Pride Nights this season, most during Pride Month, which celebrates and supports LGBTQ+ culture and rights...The Texas Rangers are the only team without a Pride Night...

In September 2003, two years after the Chicago Cubs hosted what is considered the first Pride game, the Rangers invited local LGBTQ+ groups to a game as part of a fundraising event, similar to what they do for all kinds of groups throughout each season. There were some Rangers fans **who expressed opposition through a website beforehand and, while not widespread, there were some protests outside the stadium before that game.**

LGBTQ Nation (6-9-21):

*It matters that **(almost)** all of baseball is embracing Pride now. It changes the game...*

The **activism** happening in baseball, on the corporate and individual level, sends a clear message to everyone in sports: **do something** more than change your logos or send social media posts.

Pride celebrations are becoming increasingly frequent in sports, and baseball is becoming one of the most visible games to work on being inclusive since Pride Month falls right in the middle of the baseball season.

The San Francisco Giants made history by becoming the first Major League Baseball (MLB) team to wear Pride-themed uniforms on the field...

Only the Texas Rangers are not holding an event that recognizes or celebrates Pride in some way this year. They remain the only MLB team that has not had some sort of Pride Day since 2003. That year, they invited other gay athletes to a game in September, but it drew protestors who even launched “protestgayday.com” to object to their invitation. The team hasn’t publicly celebrated the LGBTQ community since...Texas lags behind.’

Dallas Voice (9-18-15):

Gay Day at Six Flags is Saturday...

When Dallas Voice led a group of more than 30 LGBT community organizations to sponsor the 1997 “Gay Day at Six Flags Over Texas” as part of Dallas’ annual LGBT Pride celebration, then owner and publisher Robert Moore said the outing to the Arlington amusement park was “intended to provide visibility for our community and to provide some fun.”

The event — which has taken place each September since — certainly provided visibility. And that visibility brought some unwanted attention, too, as right-wing groups responded in the years to come by staging protests outside the park...

In 2002, according to Dallas Voice archives, conservative religious groups launched a boycott campaign to try and shut down Gay Day at Six Flags. They failed.

An article published online at the Christian website World Net Daily in 2004...quoted...ProtestGayDay.com, as saying that 'families...could unknowingly come to the park Saturday and 'realize that they are waiting in line for one hour at a time with flamboyant homosexuals embracing one another and kissing...'...

Gay Day at Six Flags marks its 20th anniversary this year, and as the years have passed, the protestors that had been so vigorous in waving their anti-gay signs to warn off the innocent heterosexual families **have faded away...**

For Leo Cusimano, now publisher and co-owner of Dallas Voice, it is “a reflection of the **changing times** that **we no longer see those protestors** outside the gates on Gay Day at Six Flags...Dallas Voice is proud to be a part of the movement that is creating such a positive **change in our society.**”
